Invitation for Bids for the Construction of AAMCHOWK AADHARBHUT ASPATAL

Government of Nepal *has allocated funds* towards the cost of **Construction of AAMCHOWK AADHARBHUT ASPATAL** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of AAMCHOWK AADHARBHUT ASPATAL** Contract Identification No: **ARM/NCB/WORKS/05/077/78**. Bidding is open to all eligible as per Section V of bidding document.
2. **Aamchowk Rural Municipality** invites sealed bids or electronic bids from eligible bidders for the Construction of AAMCHOWK AADHARBHUT ASPATAL under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 19,35,00,000.00**
 - Minimum Work experience of similar size and nature: **One RCC Building of Minimum Amount NRs 12,55,00,000.00**
 - **Bid capacity : Nrs. 15,68,68,168.00**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the **Office of Aamchowk Rural Municipality, Balankha, Bhojpur** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below of a non-refundable fee of 10000.00 NRs. till 2078.02.17 17:00 PM during Office hours.

7. electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00 Noon On 2078.02.18**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM On 2078.02.18** at the **Office of Aamchowk Rural Municipality, Balankha, Bhojpur**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 48,00,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
